

SPECIAL RULES OF THE “GRAND COMPETITION - FIAT 500E”

These rules set out the special conditions and the practical details specific to the “**Grand Competition - FIAT 500E**” event. For all other matters, please refer to the *General Competition Rules of the Company*, which are attached and form an integral part of the conditions applicable to the event and are available at the address www.circuscasinoresortnamur.com*.

Participation in this FIAT 500E competition constitutes full and unreserved acknowledgement and acceptance of the Special rules and the *General Competition Rules*. Any claims or disputes subsequent to the player's participation on the elements of these will not be accepted.

- A. Event name: **Grand Competition Fiat 500E**.

- B. Organizer: GAMBLING MANAGEMENT S.A., with its head office at 4000 Liège, Rue des Guillemins 129, CBE number 0859.984.677 (hereinafter the “Company”).

- C. Duration of the competition: From 26 February to 25 April 2024 for the distribution of the tickets. The final event will take place on 25 April 2024 from 20:00.

- D. Location of the Competition: Circus Casino Resort Namur, located at Avenue Baron de Moreau, 1, 5000 Namur.

- E. Territorial limits: Circus Casino Resort Namur, located at Avenue Baron de Moreau, 1, 5000 Namur.

- F. Conditions for participation:
 - Have won one or more participation tickets by playing on our game terminal and having correctly answered the 2 preselection questions.
 - Presence is obligatory within the Circus Casino Resort Namur establishment and a FIAT 500E grand competition participation ticket must be placed in the box on 25 April 2024 for the selection that will take place on the same day.

- G. The running of the FIAT 500E competition:

1. Participation in the Fiat 500E competition:

Participation in the FIAT 500E grand competition involves obligatory presence within the Circus Casino Resort Namur establishment. Participation tokens will be distributed to participants (depending on their Club status), per day and per department at the Circus Casino Resort Namur. The customer will receive a token at the Casino reception, at hotel check out, in the wellness space during a treatment or a reservation of the private spa, in the restaurant with the bill, and upon reservation of one of our seminar rooms.

The participant must:

- a. Collect participation tokens at the Circus Casino Resort Namur during the FIAT 500E grand competition period from 26 February to 25 April 2024.

- b. Insert tokens into the terminal and answer pre-selection questions correctly to get participation tickets.
