SPECIAL RULES "BIG LAS VEGAS GAME" COMPETITION

- A. <u>Competition name</u>: Big Las Vegas Game (hereinafter the "Competition)
- B. <u>Organizer:</u> GAMBLING MANAGEMENT S.A., with its head office at 4000 Liège, Rue des Guillemins 129, CBE number 0859.984.677 (hereinafter the "Company").
- C. Duration of the competition: From 6 May to 12 July 2024.
- D. <u>Competition location:</u> Circus Casino Resort Namur, located at Avenue Baron de Moreau, 1, 5000 Namur.
- E. <u>Territorial limits</u>: Belgian territories.
- F. <u>Conditions for participation:</u>
 - Must be 21 years of age or older to enter the Competition.

- G. The running of the Competition
- 1. Conditions for participation in the Competition:
