
RULES OF THE “GRAND JEU CONCOURS – MERCEDES GLC COUPÉ”

These rules set out the specific conditions and practical arrangements for the event “Grand Jeu Concours MERCEDES GLC COUPÉ”.

For all other matters, reference is made to the Company's *General Contest Rules*, which are attached and form an integral part of the conditions applicable to the event and are available at www.circuscasinoresortnamur.com*.

- A. Name of the event : **Grand Jeu Concours MERCEDES GLC COUPÉ**
Car model : **Mercedes-Benz GLC 200 d 4MATIC Coupé Star Edition – diesel**
- B. Organiser : GAMBLING MANAGEMENT SA, with registered office at 4000 Liège, Rue des Guillemins 129, company number BCE 0859.984.677, and Namur Casino Resort, with registered office at Rue des Guillemins 129, 4000 Liège, company number BCE 0654.871.150 (hereinafter, the “Company”)
- C. Contest period : From 1 September 2026 to 10 December 2026.
The grand final of the Mercedes GLC Coupé Grand Jeu Concours will take place on Thursday 10 December 2026, from 9:00 p.m.
- D. Contest venue : Circus Casino Resort Namur, located at Avenue Baron de Moreau 1, 5000 Namur.
- E. Conditions of Participation :
- Having won one or more entry tickets by playing on one of our gaming terminals available in various locations/departments of the Circus Casino Resort Namur establishment, and having correctly answered the pre-selection knowledge question;
 - Mandatory presence of the participant at the Circus Casino Resort Namur premises and submission of the entry ticket for the Grand Jeu Concours MERCEDES GLC COUPÉ in the ballot box on 10 December 2026, ahead of the selection of participants taking place on the same day;
 - Having complete and up-to-date contact details (phone number, email, etc.) in the establishment's loyalty programme.
 - Persons who won **the car** during the last three editions of the Grand Jeu Concours (Fiat 500, BMW and Range Rover) **are no longer eligible to win the car** in the current edition of the Grand Jeu Concours.

These persons may nevertheless take part in an attempt to win the other prizes.

- F. How the MERCEDES GLC COUPÉ contest works
- Participation in the MERCEDES GLC COUPÉ contest

Customers visiting the Circus Casino Resort receive an entry token at the terminal in various locations: at hotel reception upon check-out, at the wellness centre following a treatment or a booking for the private Spa, at the La Carte Du Roi restaurant when paying the bill, as well as when booking our seminar rooms and at the Casino.

Customers who visit the casino reception receive entry tokens according to their club status: 1 token for Copper members, 2 tokens for Gold members, 2 tokens for Silver members, and 3 tokens for Diamond members.

These tokens are allocated per day and per department of the Circus Casino Resort Namur (Hôtel Mercure, Wellness, La Carte Du Roi restaurant, seminar rooms, Casino).

Participation in the Grand Jeu Concours MERCEDES GLC COUPÉ requires the participant's mandatory presence at the Circus Casino Resort Namur premises for the final on 10 December 2026.

The participant must:

- a. Collect entry tokens at the Circus Casino Resort Namur during the Grand Jeu Concours MERCEDES GLC COUPÉ period, from 1 September 2026 at 9:00 a.m. to 10 December 2026 at 9:00 p.m.
- b. Insert the tokens into the gaming terminal and correctly answer the pre-selection knowledge question to obtain entry tickets
- c. Deposit their entry tickets in the appropriate ballot box on Thursday 10 December from 12:00 p.m.

If all these conditions are met, the entry ticket will be considered valid and eligible for the final prize draw of the Grand Jeu Concours MERCEDES GLC COUPÉ, on 10 December 2026.

- Finalist selection procedure:

The selection of finalists will take place on 10 December 2026, from 9:00 p.m. 20 people will be drawn at random from among the participants.

- Notification of selected participants:

The 20 selected participants must identify themselves to Circus Casino Resort Namur staff within two minutes. If a selected person does not come forward within the allotted time, a new draw will be held to determine a new selected participant.

- Participation in the Mystery Box Game:

The 20 selected finalists will then take part in the mystery box game to try to win a prize. Each finalist, in draw order, must choose one of the 20 boxes on offer.
